

### Notes to the Audited Standalone Statement of the Financial Results for the half-year ended on March 31, 2022.

1. The financial results were reviewed by the Audit Committee and approved by the Board of Directors in their meeting held on May 28<sup>th</sup>, 2022
2. The company has not received any Investor Complaints during the year and no complaint is pending as on 31<sup>st</sup> March 2022.
3. Figures of the previous period/year have been regrouped/recast wherever necessary to make the Financial Statements comparable.
4. During the year the company has issued 60,00,000/-Equity Shares through IPO @ Rs. 39/- per share (Including premium) for setting up a new manufacturing unit, working capital requirements, and general corporate purposes.
5. During the year, the valuation of closing stock has been carried out on FIFO basis at Cost or Net Realizable Value whichever is lower.
6. Provision for Deferred Tax and provision for Income Tax has been recognized in each Interim period on the estimates made by management.
7. The Company operates in one segment which comprises of manufacturing and sale of Wires & cables identified in accordance with principles enunciated in Accounting Standard AS-17, Segment Reporting. Hence, separate business segment information is not applicable.

The board of directors of the Company, which has been identified as being the chief operating decision-maker (CODM), evaluates the Company's performance, and allocate resources based on the analysis of the various performance indicator of the Company as a single unit. Therefore, there is no reportable segment for the Company as per the requirement of AS-17 "Operating Segment"

The Company has one manufacturing unit in the state of Uttarakhand and the company is supplying its product within India. Since all supplies are only domestic supplies, hence there are no Geographical segments for disclosure as the secondary segment.





8. On account of the spread of COVID-19, the company has resumed its operations in a manner aligning with directions by the Government. The management is continuously and closely monitoring the developments and possible effects that may result from the current pandemic on its financial condition, liquidity, and operations and is actively working to minimize the impact of this unprecedented situation and expects to recover the carrying cost of assets. As the situation is still continuously evolving, the eventual impact may be different from the estimates made as of the date of approval of these financial results.
